With regard to its applications in the Access Unit to Public Information of the State of Sonora , registered numbers 00227014 and 00227114 folios, records PJESUE.- 125/14 and 126 /14, which makes the approach consisting in : "I need information on how to serve legal documents on a person living in Sonora. Legal document is a petition to Establish Paternity Requesting custody of minor children." "Information on how to deliver legal documents Sonora citizen . Legal document is parenthood. (sic)," based on the provisions of Article 6 of the Constitution of the United Mexican States; 2nd fraction II , 36, 37, 38 , 41 and other applicable provisions of the Law on Access to Information and Protection of Personal Data of the State of Sonora in the agreement and issued this Liaison Unit within the records formed in connection with applications made by this channel , they will inform you that we can not continue with the requested procedure , under which : In terms of the provisions of Article 2 section XII of the General Guidelines on Access to Information public of this entity, the concept of request for access to information must be understood as the manifestation of the applicant by any means permitted by law and referred to in the guidelines, legal requirements, addressed to the obligated party to view or request copies of public information. In this sense, the application does not properly comply with the requirement referred to in Sections I and III of Article 38 of the Law on Access to Information and Protection of Personal Data of the State of Sonora, in relation to Sections I and III Article 180 of the General Guidelines for Access to Public Information of the entity providing the data of the Judicial or Administrative Unit possesses the required information, that is, name of the court, intervening parties, case number, judicial district and marking of documents you want to play or see, why we are prevented from turnarla to the leading unit in accordance with the provisions of the last paragraph of Article 166 of the General Guidelines for Access to Public Information, in connection with Article 164 of the guidelines referred to that effect in accordance with the provisions of articles 18 and 19 of the cited law is classified as restricted information or provide the same, enough to declare the invalidity of the approach worthwhile cause.

At the same time you notice that your question is very ambiguous because it does not specify what kind of legal document is required and where the person present in the State of Sonora, a court or tribunal, or another government office, and which city of the State of Sonora.
